

# LIMITED WARRANTY

Lubrication Technologies Inc. (Lube-Tech) stands by its products and provides through this limited warranty that its lubricants meet quality standards and are free of defects. These advanced products meet or exceed industry-wide performance specifications and provide long-term protection to critical engines and equipment. This limited warranty extends to the original purchaser of the products and to each transferee of the product. Lube-Tech Endurance-PRO Anti-Wear Hydraulic Oils, HP Hydraulic Oils, and Ashless Multigrade Hydraulic Oils are covered by this warranty.

### LIMITED WARRANTY COVERAGE PERIOD

- Oil must be put into service no later than (5) years from date of purchase.
- Oil changes must be completed in accordance with the equipment's owner's manual.

## **QUALIFYING CONDITIONS OF LIMITED WARRANTY**

- Correct lubricant is used for the application.
- The lubricant is changed/topped off as specified by the Original Equipment Manufacturer (OEM) and must be properly serviced according to OEM recommendations.
- Proper lubricant levels are maintained.
- Maintenance records are kept for each piece of equipment that include the description of the oil used and dates for lubricant change outs/top offs.
- Routine\* oil analysis and proper oil changes are performed on the piece of equipment.

  \*Frequency depends on the OEM recommendation and application but in no event shall it exceed quarterly oil analysis intervals.

### THIS LIMITED WARRANTY DOES NOT COVER:

- Mechanically deficient equipment due to abnormal operation, negligence, abuse, damage from casualty, shipment or accident, or equipment modifications outside OEM recommended thresholds.
- Lubricant-related failures if different products and additives are used.
- Repair or replacement of equipment due to normal wear.
- Failure of equipment due to a pre-existing condition that is unrelated to the use of Lube-Tech products.
- Situations where the OEM-required lubricant standards do not match those stated by Lube-Tech without written approval from Lube-Tech.
- Equipment and lubricant failures due to water contamination.
- Improper installation of lubricant related parts (such as, but not limited to, filters and drain plugs).

## WHAT THE PERIOD OF COVERAGE IS:

- The Lube-Tech Endurance-PRO limited warranty is valid for one year of product use in equipment when paired with quarterly oil analysis testing.
- The Lube-Tech Endurance-PRO limited warranty is only valid if the product is put in service not later than five (5) years from the date of purchase.



# **TO FILE A CLAIM, YOU MUST:**

- Contact your Lube-Tech representative within 30 days of discovering the issue. You may also contact Lube-Tech at **651-636-7990**. New and used oil samples must be submitted along with each warranty claim.
- Allow Lube-Tech to examine equipment and proof of purchase of the lubricant and operating/maintenance records for the equipment.

### WHAT LUBE-TECH WILL DO ONCE A CLAIM IS FILED:

- · Validate that the fluid caused the equipment failure through oil analysis and that the terms of the limited warranty are met.
- Lube-Tech will replace any lubricant that is defective.
- In addition, if there is equipment failure due to the product you purchased, and the engine was serviceable at the time the oil was installed, Lube-Tech will repair any equipment damage (parts and labor only) directly caused by a defect or malfunction of the product, at no cost to you, provided that the lubricant was selected and maintained in accordance with specifications of the OEM or the written instructions (which includes product packaging) of Lube-Tech, in an amount up to \$25,000 for heavy equipment.

The remedy provided here will be your only recovery against Lube-Tech. You will not be able to recover incidental damages (for example, transportation costs to and from the Lube-Tech representative for inspection of the equipment, loss of use, towing charges, bus fare, car rentals or other incidental damages) or consequential damages (the cost of repairing or replacing other property which was damaged when the lubricant was defective). LUBE-TECH MAKES NO OTHER WARRANTIES WHETHER EXPRESSED OR IMPLIED BEYOND THOSE DESCRIBED IN THIS LIMITED WARRANTY.

## **HOW STATE LAW RELATES TO THE WARRANTY**

This limited warranty gives you specific legal rights. YOU MAY ALSO HAVE OTHER RIGHTS, WHICH VARY FROM STATE TO STATE. SOME STATES DO NOT ALLOW THE EXCLUSION OF OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU.
